Entries are now open for the:  
2024 SAPRO Awards for the Best Recycled Plastic Product .  
This competition aims to acknowledge products that are made from recycled materials, thereby encouraging brand owners, retailers, converters and industrial designers to consider recycled plastics as a material of choice.

## Judging Criteria

Entries are judged on a number of criteria for example:

- Innovation in developing the product in question
- Tonnage (potential tonnages) converted
- Replacement of alternative (virgin) materials
- Technical achievements in manufacturing to overcome recycled material challenges
- Sustainability of product, i.e., Long-term demand and market acceptance of product (will it still sell in 5 years' time?)
- Measures taken to ensure product consistency and customer satisfaction despite recycled material content
- Wow Factor! Does it tell a story?

(Various weightings could be used to judge products objectively)

## Award Categories

- Flexible Packaging Products: plastic packaging made from flexible material for any application.
- Rigid Packaging Products: plastic packaging made from rigid material for any application.
- Agriculture and related products: product packaging and items used in the agricultural sector, e.g., irrigation pipes, crop protection, animal feed troughs etc.
- Household & leisure products: products such as plastic bowls, domestic ware, broom-handles, garden-chairs etc.
- Construction & Building sector: products ranging from roof sheeting, building bricks & paving to plumbing applications.
- **Overall Winner:** the overall "best-in-class" application from the above categories.
- Creative / Artisanal Solution - a new idea or small scale application for recycled plastics that creates excitement and opportunities for the recycling industry.



## How To Enter

- An entry fee of R2 500.00 (VAT included) (R1000 for Creative/Artisanal category) must be paid online via Quicket for entries to be considered (<https://qkt.io/Zn9Dbn>). Please note that failure to pay will automatically disqualify the entry.
- Email a fully completed entry form to Oliver Bonstein at [gm@plasticrecyclingsa.co.za](mailto:gm@plasticrecyclingsa.co.za)
- Each entry must be accompanied by at least two professional quality digital images of high resolution (>1MB). One image of the product and one image illustrating the product application.
- Provide us with a motivation as to what makes this product special and why it should win - max 300 words, on a separate page/document.
- The actual, physical product (sample) must be delivered to the PlasticsSA Cape Town Offices: Unit D, Olympic Park, 969 Voortrekker Rd, Maitland, Cape Town, 7460, marked for the attention of Oliver Bonstein (SAPRO), along with a hard copy of the entry form and motivation by the closing date.
- The sender should confirm that the entry was delivered via email on [gm@plasticrecyclingsa.co.za](mailto:gm@plasticrecyclingsa.co.za)
- Should entrants require the return of their entries after the competition, arrangements must be made to collect the entry from the Plastics SA offices in Cape Town.
- This year's awards ceremony will be held on Thursday, 19 September 2024 in Cape Town. During the event, the recycler of the material, the manufacturer of the product as well as the brand owner will be acknowledged. Each category will have a winner and an overall winner will also be awarded.
- Any company in Africa may enter, provided that the recycled material originated in South Africa.
- Products submitted in prior years that have not previously won an award, may be entered again.
- **Competition entries close at 17:00 on Thursday, 1st August 2024.**
